Dear Parents and Carers,

## Key Workers

I appreciate that you are receiving numerous communications from myself, however, I hope you appreciate that we are trying to plan the next few weeks in line with Government guidance.

As mentioned in an earlier communication, from Wednesday 25 March we are only open to children of key workers and to vulnerable children. We are contacting parents of vulnerable children directly to establish whether they would be best supported at school or at home.

However, we do need to gather all information regarding Key Workers. It is not a requirement that Key Workers send their children to school unless they feel there is no facility for childcare at home.

We have defined key workers as:

- National Health Service (NHS)
- School Staff
- Armed Forces
- Care home workers
- Social workers
- Police officers
- Prison officers
- Fire fighters
- Environmental Health officers
- Highways Agency workers
- Supermarket workers
- Delivery drivers

Where there are two parents in a household, if one of them is a keyworker and one of them is not it is expected that the non key worker would provide the necessary childcare. Therefore, that child **will not be in school**. For children who are at home, we will be sending home some suggested activities that they might undertake during this school closure.

Therefore, if you work in any of these sectors and intend to send your child(ren) to school from Wednesday 25 March please complete the form on our Coronavirus page of the website.
