# Dear Parent / Carer,

# We know how important it is for you to be able to send your child to school.

The Bourne Academy is taking a number of measures to help prevent the spread of Coronavirus, including:

- Encouraging all staff to test regularly, to minimise the risk of our teachers giving your child or other children Covid19
- Ensuring our staff and children practice good hygiene
- Making sure our spaces are well ventilated
- Encouraging all members of our community to isolate and book a <u>PCR test</u> should they develop symptoms of the virus.

### We are also asking all parents to encourage their children to test regularly and to report each result.

Up to one in three people who have COVID-19 can spread the virus without knowing. This is because they have no symptoms. We are therefore asking all parents to encourage their children to test every Sunday and Wednesday and help us to keep The Bourne Academy open. This letter has gone out to all parents of children at the Academy asking them to regularly encourage their children to test and to report each result.

Your child is able to collect home test kits after their weekly assembly or from Reception and bring them home with them. Please ask your child if they have received these and help them to take the test and report their results. Testing is free of charge.

The tests will come with guidance in multiple languages on how to take the test. You can also see this useful video to show you how to take the test - tests usually take a few minutes to do and you get the results in 30 minutes. Then all you need to do is to report the result to:

### Financial support is available if your child tests positive and you need to self-isolate.

If you are unable to work due to your child having, or displaying symptoms of, COVID-19, you may be entitled to a one-off payment of £500 through the <u>NHS Test and Trace Support Payment scheme</u> if you are required to stay at home and self-isolate.

You will be eligible if you live in England and meet all the following criteria:

- You have been asked to self-isolate by NHS Test & Trace or NHS COVID-19 app
- You are employed or self-employed
- You cannot work from home and will lose income as a result
- You are claiming at least one of the following benefits:
  - 1. Universal Credit
  - 2. Working Tax Credits
  - 3. income-related Employment and Support Allowance
